# CISD Show Choirs Performer Contract

I, \_\_\_\_\_ (student) understand the expectations involved with being a part of the CISD Show Choirs and I will adhere to all schedules and regulations related to it. I also understand that failure to be eligible under UIL rules or failure to attend rehearsals without parent consent will result in removal from the group at the director's discretion. A warning of impending removal will be given before removal is enacted if the removal is based on discipline. If the removal is eligibility related, no notice is necessary. The director reserves the right to remove a student at anytime based on her discretion. 2 unexcused absences results in removal from the ensemble. 4 tardies results in removal from the ensemble.

I, \_\_\_\_\_ (parent) know that my student is auditioning for the CISD Show Choirs. If chosen they will be required to attend specified rehearsals and performances related to show choir. Also, monetary commitments must be met in a given timeline. I understand that failure to do so may result in the student's removal from the group. See student information above.
